

stars participants fly carbon neutral

The idea to offset the emissions caused be stars participants' travelling to and from the symposium, was initiated by Emmanuel Hess, Alumnus of stars in Stein am Rhein 2011. He introduced stars to the National Forestry Financing Fund of Costa Rica (FONAFIFO) who certify the offsetting of emissions with the help of CDG Environmental Advisors.

The goal of the FONAFIFO (www.fonafifo.go.cr) is to protect and conserve Costa Rican forests. They promote a responsible and sustainable management of the country's forest coverage through monetary incentives to enable ecosystem restoration and reforestation programs. As part of this initiative, FONAFIFO has created a program called "Viaje Limpio" ("Clean Journey"). Through this, organizations or individuals can calculate their green house emissions of a trip and compensate these by purchasing Certificates for Environmental Services. With this Certificate, the Costa Rican Government confirms that the journey was therefore "Clean", or as others might state, "Carbon Neutral". The funds collected from the certificates are used to protect and restore seven thousand hectares of forest coverage in Nicoya, Santa Cruz, Filadelfia, Carrillo and Liberia, all located in Guanacaste, Costa Rica.

CDG Environmental Advisors (www.cdg-ea.com) introduced the concept of integrated environmental and social consulting in Costa Rica. Their services include the creation of corporate policies and regulations, design and implementation of private protection systems and environmental and social management systems. CDG's newest division is the Carbon Management division, which specializes in carbon footprint calculations, carbon offset project definition and design, and certification advisory services.
